AMENDMENT TO UPHAM FARMS CONDOMINIUM MASTER DEED

There is recorded herewith a set of floor plans for the Buildings in Phase II by Charles Basile, Registered Architect, showing the layout, location, Unit numbers and dimensions of the Units in Phase II and stating that the Buildings have no names and bearing the verified statement of Charles Basile, Registered Architect, certifying that the plans fully and accurately depict the layout, location, Unit numbers and dimensions of the Units in Phase II, as built.
